# WILL PATTERSON, JR. SENTENCED TO 88 ACTIVE YEARS IN ATTEMPTED AGGRAVATED MURDER, MALICIOUS INJURY TO LAW ENFORCEMENT OFFICER AND ALL REALTED CONVICTIONS

**PORTSMOUTH, VA** – After a three-day jury trial (September 7-9, 2022,) the defendant, Will Patterson, Jr., was found guilty of twelve (12) counts, including attempted aggravated murder, aggravated malicious wounding, malicious injury to law enforcement officer, three (3) counts of use of a firearm in the commission of a felony, four (4) counts of shoot in public with bodily injury, carry concealed weapon and possession of a firearm by minor, in the shooting of Portsmouth Police Officer Angelina Baaklini White.

Based on legislative changes, post July 1, 2021, defendants have a right to select a jury sentencing or to be sentenced by the judge of the circuit court, who presided over the jury trial. In this instance, the defendant, Will Patterson, Jr., opted to be sentenced by the judge of the circuit court, who presided over the jury trial.

Today, April 12, 2023 Will Patterson, Jr. was sentenced to 160 years with 54 years suspended (18 years active and 4 years suspended of which are to run concurrently with other charges) and 5 years of supervised probation for a total active period of incarceration of 88 years. The trial team consisted of Senior Assistant Commonwealth's Attorney Haille Hogfeldt and Assistant Commonwealth's Attorney Camden Freeman.

### Sentencing Breakdown – To obtain record information please contact the Circuit Court Clerk

Count 1 - Attempted Aggravated Murder: 60 years w/ 30 years suspended and 5 years of supervised probation

Count 2 - Use of Firearm in Commission of Felony: 3 years

Count 3 - Malicious Injury to Law Enforcement: 30 years w/ 10 years suspended

Count 4 - Use of Firearm in Commission of Felony: 5 years

Counts 5-8 - Shoot in Public Causing Injury: 5 years/1 year suspended on each count. *Counts 5-8 are served concurrently with count 1.* 

Count 9 - Concealed weapon: 12 months

Count 10 - Weapon by Minor: 12 months

Counts 9 and 10 are to be served concurrently with count 3.

Count 11 - Aggravated Malicious Wounding: 35 years w/ 10 suspended.

Count 12 - Use of Firearm during commission of felony: 5 years *All other counts are to run consecutively*
